NOTICE TO CONTRIBUTORS

Original papers should be addressed to Dr. Philip R. Evans, Department of Child Health, Guy's Hospital, London, S.E.1. Papers are accepted on the clear understanding that the subject matter has not been and will not be published in a separate journal. Permission to re-publish must be obtained from the Editor.

Papers should deal with original matter and the discussion should be limited to relevant questions. Contributions should be as concise as possible and a short summary of conclusions should accompany each paper. Manuscripts should be typewritten and carefully revised, as alterations in print are costly and, apart from verbal corrections, will be charged to the contributor.

Illustrations should be prepared for reproduction. On the figures lettering which is written in pencil will be replaced by printer's type without charge.

References to papers in the text should be made by inserting the name of the author followed by year of publication in parentheses. At the end of the paper, references should be arranged in alphabetical order of authors' names. Such references should give author's name, followed by initials and year of publication in brackets. The name of the journal in which the article appeared should follow and should be abbreviated according to the *World List of Scientific Periodicals*. The volume number should be given next in arabic numerals, followed by number of first page of article, thus:

Cowan, J. (1929). *Quart. J. Med.*, **22**, 237.

Reprints. Fifty reprints will be given to the author or divided among the authors. If desired, further reprints may be obtained by application to the Publishing Manager, B.M.A. House, Tavistock Square, but notice must be given when the proof is returned.
